The Earnest Money should be deposited by receipt of Treasury Challan /Deposit at call receipt of a Scheduled bank/ Fixed deposit receipt of a Scheduled bank / Demand Draft of Scheduled bank and submitted along with the application requesting the tender schedules. The Earnest Money should be drawn in favour of the Commissioner, Oulgaret Municipality, Puducherry.

Both the cost of tenders forms (including VAT @ 4%) and EMD amount, in the form of demand draft payable to the Commissioner, Oulgaret Municipality, Puducherry should be enclosed along with the downloaded tender schedule in separate covers along with the enlistment copy. Tenders submitted without the above will be summarily rejected.
5. If the opening day of tender happens to be public holiday the same will be opened on the next working day.
6. The time allowed for carrying out the work as noted in column No.7 of the table above will be including monsoon period and shall start from the 10th day after the date of written order of commencement of the work.
7. The tenders of the contractors who do not deposit earnest money deposit in the prescribed manner will be summarily rejected.
8. The Council reserves the right to reject any (or) all the tenders without assigning any reasons thereof.
